## ii) Other Updates

- **Planning** TWC have been consulted on an Application for the approval of reserved matters (appearance, landscaping, layout and scale) for Phase 2A (the Cooling Towers phase) residential development pursuant to outline planning permission 19/05560/OUT 19/05560/OUT.
- **Development Plans** Local Plan Update: The local plan regulation 19 version, updated SCI and Local Development Scheme are due go to cabinet in December. It will then proceed to full council followed by a final chance for public and stakeholders to comment on the soundness of the plan. Further detail will be set out in updated Local Development Scheme. The WHS policy has been slightly updated based on comments received through the consultation process, but details are yet to be finalised.
- **Highways, Engineering & Project Delivery** Scheduled works are limited at the moment other than the de-silt of Upper Furnace Pool this is starting in the next week for 4-6 weeks.
- Environmental and Neighbourhood Services (AC) Dale End Play Area refurbishment progressing well, it was hoped to be open in time for half term, all being well the area will be open by the end of next week. The flower beds in Dale End and Galleon / Jockey Bank parks have been replanted to refresh and adaptive to climate change.
- **Culture (JB)** suggested that Sarah Bird may be able to provide a comment in respect joint push for tourism between SC and TWC. World Heritage Festival back in Sept. Annual Coracle Regatta during August Bank Holiday. Secret7 art trial events at Fusion Gallery. Annual Ironbridge Open Day with Morris Team, Dog Show etc. Cultural Ambitions funded by Arts Council.

**Clir Healy** – Community Projects – meeting a group looking to erect a memorial in respect of the Coalport Ferry Disaster and the campaign to relocate the Bartlett Memorial Fountain back into The Square.

## **Shropshire Council**

- **(CB)** Planning App to erect a bungalow on edge of woodland in Broseley. Outside WHS but visible from the WHS.
- (LE) Officer predominately dealing with the Power Station applications, happy to answer any specific questions. CH on behalf of PC recognised that applications all sit within SC following the grant of the Outline but requested continued engagement as scheme has significant implications on The Gorge and TWC. LE confirmed that a Newsletter / Website is being produced by Harworth. VH flagged that Ward Member/ PC engagement / Liaison is a condition of the consent. VH/LE to have further conservation.

## **Broseley Town Council**

• (IW) update on a tricky planning application in Jackfield (SCouncil). Likely that a new planning application may be submitted following previous application being allowed at Appeal. IW asked about the potential reinstatement of the railway. LE advised that SC and developer had met NE. Use of Albert Edward Bridge to carry mineral out of the site would cost £15-18m. Therefore there is a current variation of application under consideration to allow egress of mineral by road. Potential for use as a passenger railway are still under



consideration. KS wrote regarding this matter in the summer. CB highlighted issues on highways and tourism which KS noted he did include in his comments, although did note the number of road trips were not significantly higher and adherence to routing agreement fundamental.

## The Gorge Parish Council

• **(MB)** Sent apologies Cllr Healy provided the following updates. PC particularly pleased that the Roberts Rd planning appeal was dismissed (20 affordable dwellings sitting just outside the WHS). PC has two operatives who maintain the public realm in addition to TWC. Red BT telephone box purchased and retained in Coalford to potentially be used as an Interpretation facility.

## **Madeley Parish Council**

• (RE) sent apologies.

## Ironbridge Gorge Museum Trust

• (RH) National Heritage Memorial Project continues at pace with scaffolding around The Toll House be removed with full completion soon. Moving on to Museum of Iron including the Clock Tower next. Blists Hill fencing (2.1km fence along Legges Way / Coalport Rd). Local exhausts project at Blists Hill undertake to allow continued demonstrations. The Inclined Plane is the most exciting project with work to The Engineer House, tree removal and landscape improvements. Flooding – the overarching point is that visitor numbers are down and RH questioned if this was consistent across the piste. Number of temporary traffic speed limits along Buildwas Rd would benefit from a review. LE advised that these issues have been raised with the developer with a view to being rectified. VH advised that some works will take place as part of s278 around the access as well as other works secured within the s106 closer to Ironbridge.

#### Severn Gorge Countryside Trust

• (JB) Financial means is the biggest driver at the moment and fundraising is their major focus as well as independent contracting.

Severn Valley Water Management Scheme a long term project looking at the storage of a significan amount of flood water to hopefully alleviate flood issues downstream. Bathing Water data collected (May – Sept) to gain clarification on water quality published on SwimFo website. Not just of interest to bathers but dog walkers, and water based activities (canoeing, paddle boarding) etc.</li> </ul>
